Authorizing Commencement of Action to Obtain an Order Directing the Demolition and Removal of a House at 3022 Seneca Castle Road

WHEREAS, the house at 3022 Seneca Castle Road owned by David P. and Jodie R. Ross has been in violation of local and state property maintenance Codes for some time and has been deemed to be not habitable, beyond repair and dangerous and unsafe to the public; and

WHEREAS the Code Enforcement Officer of the Town of Seneca has recommended that the Town Board authorize the Town to commence a legal action in the Ontario County Supreme Court to obtain a Court Order directing the demolition and removal of this building and collection of all costs of demolition, including reasonable and necessary legal expenses; and

NOW, THEREFORE, BE IT RESOLVED, that the Town of Seneca be and it hereby is authorized to commence a legal action in the Ontario County Supreme Court seeking to obtain an order authorizing the demolition and removal of the house and structure located at 3022 Seneca Castle Road and to collect the costs of demolition, including reasonable and necessary legal expenses incidental thereto.
