Meter pits for 1 ½" and 2" services will be supplied and installed by applicant per Town of Seneca specifications. When water services require a backflow preventer, allowed in a meter pit, the cost of a properly sized pit and installation will be the responsibility of the owner. Also, the fee for repairing services is \$100.00 per hour plus parts. The option is given to have Seneca Water Dept. do the work or a private contractor may be hired. However, if the resident chooses a private contractor, the work must be performed within one week, or the water district will do the work at the rate listed above.

Approve Amended Intermunicipal Agreement with Town of Geneva

WHEREAS, the Town of Seneca and the Town of Geneva have previously entered into an Inter-Municipal Agreement relating to the supply of potable water by the Town of Geneva to the Town of Seneca and the transmission of water through the Town of Seneca system for re-purchase by the Town of Geneva, and

WHEREAS, the parties have currently agreed to enter into a water improvement project that is generally described as the rehabilitation of the existing tank, installation of a new tank and general improvements to the system wherein the Town of Geneva will contract for and construct the contemplated improvements and the parties shall share the costs associated with said project and otherwise cooperate with each other pursuant to the Inter-Municipal Agreement, and

WHEREAS, the parties feel it appropriate to amend the said Inter-Municipal Agreement dated April 29th, 2009 and revised on November 13th, 2009 to provide as follows:

1. The Town of Geneva shall have the authority to contract for and construct the water improvements project described above.
2. The Town of Geneva shall have access to the project and improvements for the purposes of repair and maintenance for the useful life of tanks.
3. All other terms and agreements contained in the original Inter-Municipal Agreement dated April 29th, 2009 and revised on November 13th, 2009 and as amended shall remain in full force and effect.

WHEREAS, the approval of the Inter-Municipal Agreement Amendment is needed to move forward with this project.

NOW THEREFOR IT BE RESOLVED, the Town of Seneca approves the amendments made to the Inter-Municipal Agreement with the Town of Geneva.
