Authorization to Accept Fuel Quotes

WHEREAS New York State has updated their fuel contract beginning in March 2019 and it no longer includes non-ethanol fuel; and

WHEREAS in accordance with the Town of Seneca Procurement Policy, the Highway Superintendent has made a good faith effort to collect written quotes for the supply and delivery of non-ethanol fuel; and

WHEREAS it is the recommendation of the Highway Superintendent to accept the 2021 quote from NOCO Energy Corporation: and

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Seneca hereby accepts the quote from NOCO and authorizes the Highway Superintendent to execute the ongoing purchase of non-ethanol fuel in accordance with the Town of Seneca Procurement Policy.

Approve the 2021 Excavation Permit for Gas Installation

WHEREAS New York State Electric and Gas corporation (NYSEG) has requested a blanket permit from the Town of Seneca to install gas services within the Right-Of-Way on all Town Highways from January 1, 2021 thru December 31, 2021; and

WHEREAS it is the recommendation of the Highway Superintendent to authorize this permit; and

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Seneca hereby authorizes the 2021 excavation permit for NYSEG and directs the Highway Superintendent to sign and return said permit.

Resolution #45-21

Revise & Adopt the 2021 Town of Seneca Fee Schedule

WHEREAS the Town Board of the Town of Seneca wishes to provide residents with a comprehensive schedule of town fees that is clear and accessible to all; and

WHEREAS the Town Clerk presents the Town of Seneca Fee Schedule document detailing town fees for all departments; and

WHEREAS a couple of revisions need to be made to said fee schedule on the Water & Sewer table; and

WHEREAS (1) the rate for water sold to town residents per thousand gallons after 6,000 will increase from \$2.80 to \$2.85; (2) the rate for water sold to the Town of Benton and Hopewell per thousand gallons will be changed from \$2.75 to \$3.14 (per the IMA); (3) the rate for Sewer Installation in the Town of Seneca will decrease from \$10,000 to \$2,000 per the Sewer Rate Study; and (4) the Sewer Consumption Rate will change from \$5.00 per thousand gallons to a minimum of \$150 up to 3,000 gallons and \$7.53 per thousand gallons thereafter.

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Seneca hereby makes said revisions to the Town of Seneca Fee Schedule and directs the Town Clerk to make those changes on those lines of the fee schedule and post this document at the Town Hall, on the Town's Website and in any other appropriate locations.

Authorization to Accept Residential Composting Contract

WHEREAS the Town Board of the Town of Seneca wishes to provide residents with a composting program; and

WHEREAS it is the Town Supervisor's recommendation to approve a contract with Impact Earth; and

WHEREAS said contract will start with a monthly pickup and replacement of 2 64-gallon totes located at the Town's transfer station. Town residents can place their acceptable household compost waste in these totes. The town will work to educate and promote this program by having information on acceptable household waste available at the town hall, on the town's website and Facebook page.

WHEREAS the monthly cost at the expected usage for this program is \$40.00/ month for a total 12-month cost of \$480.00 at which Impact Earth will try to adjust the usage of said contract as needed; and

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Seneca hereby accepts the contract from Impact Earth for a residential composting program.
