Supervisor Wickham opened the Public Hearing for Local Law #2 of 2021 at 5:00 PM. This Local Law will establish that the town opts-out of allowing cannabis retail dispensaries and on-site consumption sites. Supervisor Wickham offered the floor to anyone who wished to comment in favor of or against this local law. Supervisor Wickham made mention that a Town Resident commented to him that they agreed with the Town of Seneca deciding to opt-out of this law. He was pleased to hear feedback on this. With that, all persons desiring to be heard and having been heard, the public hearing for Local Law #2 of 2021 was closed at 5:02 PM.
