Authorization to Accept Fuel Quotes

WHEREAS New York State has updated their fuel contract beginning in March 2019 and it no longer includes non-ethanol fuel and in accordance with the Town of Seneca Procurement Policy, the Highway Superintendent put the Town of Seneca Fuel Requirements out to bid on March 5th, 2021 with a bid opening day of March 12th, 2021; and

WHEREAS The Town of Seneca received fuel bids from NOCO Energy Corporation and Hometowne Energy that both met the requirements of the Town of Seneca; and

WHEREAS it is the recommendation of the Highway Superintendent to award the lower bid from NOCO Energy Corporation which is a 2-year contract of 90 Oct Conventional Gasoline. NOCO will provide delivery twice per month at a cost of +0.24 cents per gallon based on a cost over rack, day of delivery; and

NOW THEREFORE BE IT RESOLVED the Town Board of the Town of Seneca hereby accepts the bid from NOCO Energy Corporation and authorizes the Highway Superintendent to execute the ongoing purchase of non-ethanol fuel in accordance with the Town of Seneca Procurement Policy.
