Authorize Purchase of Pickup Truck for Water Department

WHEREAS, the Town of Seneca 2021 Adopted Budget includes funds for the purchase of a Pickup Truck for the Water Department; and

WHEREAS, two truck quotes were presented for consideration under the NYS OGS Contract #PC69149; and

WHEREAS, quote #32209 from VanBortel Ford for a 2021 Ford F-150 XLT, Supercab 4x4, with a 6.5' Box for \$35,040.75 and a quote prepared by Friendly Ford for a 2021 F-150, Regular Cab 4x4, with a 8' Box, and many add-on items for \$32,759.27; and

WHEREAS, it is the recommendation of the Water Superintendent to approve the purchase of the truck from Friendly Ford with consideration of price and add-on items; and

NOW THEREFORE BE IT RESOLVED, the Town Board of the Town of Seneca hereby approves the purchase detailed in the quote from Friendly Ford and authorizes the Water Superintendent to complete any necessary documentation to execute this purchase for a total cost not to exceed \$32,759.27 to be charged to the 2021 Adopted Budget line SW1-8340.2 (Water Transmission & Distribution – Capital Equipment).
