TOWN OF SENECA HIGHWAY DEPARTMENT APRIL 2024 MONTHLY REPORT

Town of Seneca Highway Department report from March 14, 2024 to April 15, 2024.

- > Rebuilt and serviced the Midland road widener.
- > The past month we treated the roads on 6 day, 9 trips and used approximately 245 tons of salt mix.
- > Took down snow fence along with road markers and put them away.
- Cleaned 750 feet of ditch South of 4869 Wabash Road.
- Removed sidewalk at 3038 Seneca Castle Road at the home owner's request.
- Replaced the chain and bearings on the all-season body on Truck #8.
- ➤ We helped the water department with a water main break at Sensineg's on 5&20.
- ➤ Kidder Road culvert project has hit another road block. Hunt, Lane Enterprises and Ontario County Soil and Water are working together to resolve the issues.
- > Removed a tree that took down wires and was blocking the road in front of the town hall.
- ➤ I had Turner from Penn Yan install battery disconnect switches on all five of our ten-wheel dump trucks. This is mandatory on all plow equipment and after talking with other municipalities that have had fires, I decided to hire it out to avoid litigation if something were to happen.
- > Sent Pat to sewer and water school in Seneca Falls for credits towards his water and sewer licenses.
- > Cleaned 100 feet of ditch on Prospect Hill Road at the intersection of Fort Hill Road.
- > Drafted and signed a letter to Supervisor Wickham that releases John Hollowell from his probation as of April 24th.
- Serviced 2020 Chevrolet pickup. The next morning a deer ran into the driver's side rear door and box causing \$6,000 damage.
- ▶ Brian and I visited the Viking Harrisville, NY shop to look over and check specs on the International ten-wheel dump truck that we ordered in February of 2022 and was delivered to them on December 2023. We also visited the Viking Oakfield NY shop to see if the Mack ten-wheel dump truck that we ordered in August of 2023 and is scheduled to be built April 17, 2024 can be delivered to that shop to be outfitted any faster. It was agreed to send the Mack to the Oakfield NY shop with the possibility on receiving both trucks around October this year.
- > All of the highway department along with Cordell from the water department attended the Certified Excavator renewal training in Penn Yan put on by UDIGNY.
- > Cleaned ditch and installed culvert at 1841 Scoon Road.

Olsen Tank Site

- The Insertion Valves were installed for the incoming and outgoing lines

Highlights of monthly activities – Zoning Office:

I am working on three more houses on Orleans Road. One is empty and I spoke with the bank and property management company. This should be cleaned up within the next two weeks and they are prepping for sale within the next few months. I am working to contact the owners of the other two.

Th renovations for the pavilion will be completed in September with removing the fireplaces, opening the center wall up, and placing a furnace room with forced air heat.

I am in meetings with the owners of the Silos of Seneca, the wedding and event venue on Redman Road. They may attend Town Board meetings regarding the zoning on this property. As you may recall, they received a special use permit to operate a home business on this property. Home businesses are supposed operate within an enclosed building. The Zoning Board granted permission for them to have wedding ceremonies in the yard, and use an outdoor courtyard area, open gazebo, and future open deck for customers to congregate on. Throughout that process I indicated that the town would likely look at the zoning and uses to determine if we should change zoning for a use of this nature. To date, the owners have not had an event at the facility since approvals were granted. At the March ZBA meeting the board renewed the special use permit for another year. The owners are seeking to substantially change the way the event center operates in that they would like to utilize the entire property, outside of the buildings to host many types of events such as flea markets, food truck shows, yard sales, outdoor dinners, etc.

I met with the owners this morning to go over several of their concerns, many of which were taken care of by simple clarification of the approvals and determinations of what was included in the approval. Some of their requests will be removed as questions were already answered.

Throughout the conversation with the board, I indicated that the committee looking at this would be recommending to the Town Board to add an event venue to the list of home businesses within the AG district as it was determined that it was preferred to have the owner live on site. The owners are not satisfied as long term they do not want to have to live on the property and want essentially unlimited use of the property, inside and out. I also indicated that the Town Board has NOT received the recommendations yet and would make the final decision. I instructed owners to speak with Supervisor Wickham with their concerns and ideas and he would proceed with the board and committee. They may be at tonight's meeting to observe and introduce themselves.

We have several items that will be going through the approval process.

A new local law for the administration of the building code. This is a NYS item and we need to update our local law. I have it finished and given it to Haley. It will go to Mike Roulan and be ready to present at May's meeting. To begin the adoption process.

We have short term rental, Comprehensive plan, and Zoning updates all nearing completion. I expect these to be ready to present to the Town Board in the May or June timeframe. The committees will present to the board and request the board review. Once approved by the board we can begin the formal adoption process. As we near presentation of these to the board I will outline the adoption process and tentative timeline. The process takes 2-3 months once the board approves the language in concept.

Assessor's Report April 16, 2024

Change of assessment notice will be going out any day. Tentative Roll will be published and available May 1st. Value changes this year are for new construction and removal of buildings. I will be available to meet with property owners to answer questions or concerns over their new assessment.

I will be in attendance with the Tentative Roll by appointment the following dates and times Thursday May 9th noon – 4pm, Thursday May 16th 10am – 2pm, Saturday May 18th 9am – 1pm and Tuesday May 21st 4pm – 8pm here at the Town Hall.

Board of Assessment Review training will be coming up. New member Dale Heinzman will be attending, along with reappointed Board Member Colleen Cappiello. All members are welcome and can attend, however only new & reappointed members are required to attend. This training does an excellent job in preparing BAR members for the job at hand. Grievance Day is scheduled for Tuesday May 23rd 4pm – 8pm appointments are highly recommended.

Ag land conversion notices (property that has been receiving an Ag Exemption with in the last 5 years and has been improved with no Ag buildings) and charge back notices (properties that had Sr. Exemption, or Veterans, etc. exemption that was sold and the new owner does not qualify) are also in the process of being finalized and mailed out to property owners. Property owners have the right to appeal against any of these findings with the Board of Assessment Review.
