Accept Water Pipe and Appurtenance Bid

WHEREAS the Town of Seneca published 2 Bid Notices in the Finger Lakes Times on April 1, 2023, for a bid opening on April 14th, 2023; and

WHEREAS one bid was for pipe and the other for appurtenances to complete a Water District extension on Fort Hill Road; and

WHEREAS The Water Superintendent received bids from 3 companies for both the pipe and the appurtenances. Those companies were Core & Main, F.W. Webb, and Blair Supply Corporation; and

WHEREAS it is the Water Superintendent's recommendation to award the bid to the lowest responsible bidder that met all of our requirements for the materials. That bidder is Core & Main with the appurtenance bid at \$34,782.00 and the Pipe Bid at \$53,856.00; and

NOW, THEREFORE, BE IT RESOLVED, the Town Board of the Town of Seneca hereby accepts the recommendation of the Water Superintendent and awards the bid to Core & Main for the Fort Hill Road Water District Extension in an amount not to exceed \$88,638.00.
