Town of Seneca Park Policy

Use of all Town facilities is strictly subject to compliance by permittees with all federal, state and local laws, regulations, rules and ordinances, including but not limited to those relating to public behavior: possession and consumption of alcoholic beverages; and motor vehicle operation. A copy of the Town of Seneca Park Rules and Regulations is available for review at the Seneca Town Hall. The Town of Seneca Code Enforcement Officer and authorized agents shall enforce park regulations, and revoke any permit and direct any person to leave any park premises.

In the event an application is submitted for permission to use Town of Seneca facilities for an organized sporting event (e.g. league softball), the applicant shall provide to the Town a certificate of liability insurance with the Town named as an additional insured or the applicant and each person participating in the organized sporting event must execute the Town of Seneca Hold Harmless Agreement. Each Hold Harmless Agreement shall be securely attached to this application at the time of submission, and only those individuals whose names appear on the attached Hold Harmless Agreement shall be allowed to participate in the organized sporting event.

Any person or group that violates any Park rule or policy may be subject to immediate removal, banned from future use of Park facilities, loss of deposit or subject to criminal charges. The Town (Town of Seneca) reserves the right to revoke any permit and refuse an individual or group use of Town facilities if it is deemed in the best interest of the Town.

Surveillance cameras are in use at all times within the Park.

Reservations for all Town Park facilities may be made at the Town Hall during regular business hours. The Park is a "Carry in – Carry out" facility. All patrons are responsible for cleaning up and "carrying out" their trash after using the Park.

Reservations for all park facilities are on a first come basis. Reservations for January and February dates can be made beginning November 1 of the prior year. March through December dates can be reserved beginning the first business day in January.

Park Rules

Hours November 1 - April 30: 6am to 6pm

May 1 - October 31: 6am to 9pm

- 1. No person in a park shall use any portion of the picnic areas or any of the facilities for the purpose of excluding other patrons, except by those holding a permit granted by the Town, nor should any person use such facilities for an unreasonable amount of time when the park is crowded.
- 2. A permit is required for alcohol consumption. Alcohol can only be consumed in the Pavilion. This does not allow individuals or groups using picnic facilities outside the pavilion to consume alcohol.
- 3. Motorized vehicles are prohibited on park property with the exception of parking lots and drives providing access to parking lots from the road. All vehicles must be driven in a safe manner and driver must adhere to all parking and traffic regulations.
- 4. Profanity, abusive language, fighting, public intoxication, or persons under the influence of drugs, possession of drugs or disturbing the peace will not be allowed and may also face criminal charges.
- 5. No person shall deface, destroy, remove or disturb any part of park property. Violators will be subject to criminal charges.
- 6. No person or group can operate any remote controlled equipment, vehicles of any nature including but not limited to airplane, boat, helicopter, parasail, hang glider or hot air balloon, unless otherwise designated by the Town.
- 7. No person or group can ride or drive any horse or animal within the park except in parking lots and driveways.
- 8. Fires are permitted only in grills provided and are limited to customary materials, such as charcoal briquettes for preparation of food products.
- 9. Skateboards, rollerblades and roller-skates are not permitted in the parking lots or in the Park.
- 10. No person or group can conduct or participate in any tournament, camp, or organized sporting activity which has not been specifically authorized by the Town.
- 11. Glass containers are prohibited outside of the pavilion.
- 12. Pets must be on a leash at all times and pet owners must clean up any mess left by their pets.
- 13. No person shall appear nude in public, dress or undress in areas other than facilities provided for such purpose.
- 14. Fireworks are prohibited.
- 15. Wildlife shall not be disturbed. Hunting and trapping are prohibited.
- 16. Vending is allowed by permit only.
- 17. Groups using the park facilities shall provide supervision at a ratio of one adult, age 21 or older, per 10 minors.
