APPLICATION FOR WATER SERVICE

This application is made by the undersigned as owner, or person duly authorized to act as officer, attorney, or agent for owner, concerning lands of owner situated in the Town of Seneca, Ontario County, New York.

Applicant agrees to connect to a public water system in the Town of Seneca and purchase water therefrom at the following quarterly rate:

- The applicant agrees to purchase from the water district for a specified fee, a service connection from the water main to a point at the property of right-of-way line of the applicant. This to include the cost of all labor and materials for such a service and including cost of the water meter, with title to the meter remaining in the water district and use to be subject to the rules and regulations to be adopted for water system users in such proposed district. Users requiring larger service connections will be charges a proportionate fee. A fee for the meter plus time and materials for providing the water service will be charged. Check One:
